1. GENERAL

- 1.1 The promoter of the Promotion is the Hawthorn Football Club Ltd (ACN 005 068 851) (Promoter).
- 1.2 By entering this Promotion, Entrants agree to be bound by these Terms and Conditions. Information on how to enter and prizes form part of these Terms and Conditions.
- 1.3 For the purposes of the Terms and Conditions, the Promoter includes all related and subsidiary companies, past, present and future officers, agents, representatives, employees and assigns.
- 1.4 This Promotion is governed exclusively by the laws of Victoria.
- 1.5 Unless the contrary intention appears, a reference in these Terms and Conditions or in any advertisement relating to the Promotion, to Australian dollars, dollars, AUD\$ or \$ is a reference to the lawful currency of Australia. All references to dollar amounts are inclusive of goods and services tax (GST).

3. ELIGIBILITY

4. ENTRY

- 1.1 To enter this Promotion, Entrants must complete the Entry.
- 1.2 Entrants will be manually entered. The Promoter reserves the right to reject an Entry if it reasonably forms the opinion that an Entry has been created and/or submitted using automated entry means or a computer entry service.
- 1.3 The Promoter reserves the right, at any time during, or after the Entry Period, to verify the validity of an Entry and to disqualify an Entrant for tampering with the Entry process or for submitting an Entry that does not, in the Promoter's sole discretion, comply with these Terms and Conditions.

- 1.7 Entrants consent to the Promoter using the Entrant's name, likeness, image and/or voice (including photographs, film and/or recording of the same) in any future promotional, marketing and publicity purposes in any media worldwide for an unlimited period without remuneration.
- 1.8 The Promoter will obtain the Entrant's express opt-in consent before the Promoter shares the Entrant's personal information with any third-party company for marketing purposes. If Entrant gives the Promoter their express opt-in consent, they can ask the Promoter or third parties to stop sending them marketing communications at any time by contacting the Promoter.
- 1.9 Each Entrant warrants that the use or publishing of any entry will not cause The Promoter to be in breach of any third party's intellectual property rights.

5. THE DRAW

- 1.12 The Promotion will be drawn at random via electronic draw.
- 1.13 The Promoter's decision is final and the promoter will not enter into any correspondence regarding the result.
- 1.14 The Promoter shall not be liable for any loss or damage whatsoever that is suffered by any entrant (including but not limited to indirect or consequential loss), or for any personal injury suffered or sustained, except for the liability that cannot be excluded by law.

6. WINNERS

- 1.15 The winner will be notified in accordance with the Notification.
- 1.16 Five (5) winners will be selected.
- 1.17 If due to any reason whatsoever the Promoter becomes aware after an Entrant has won the Prize that the Entrant has not complied with these Terms and Conditions, that Entrant will have no entitlement to the Prize, even if the Promoter has announced them as the winner and that Entrant will be required, at the direction of the Promoter, to return, refund or otherwise make restitution of the Prize.
- 1.18 In the event that a winner is unable to be contacted, and all methods of communication are unsuccessful, or a winner does not respond to the Promoter's initial communications within two week], a redraw for any unclaimed prizes may take place on Thursday, 30 July 2024, subject to any directions from a regulatory authority. 7. PRIZES

- 1.21 The Prize will be delivered according to the Prize Conditions.
- 1.22 The Promoter shall not be liable for any costs associated with the Prize after delivery. Once the Prize has left the Promoter's premises, the Promoter takes no responsibility for any element of the Prize that is damaged, delayed or lost in transit.
- 1.23 The Promoter shall not be liable for any loss or damage whatsoever that is suffered by any Entrant or winner (including but not limited to indirect or consequential loss), or for any personal injury suffered or sustained as a result of taking the Prize, except for the liability that cannot be excluded by law.

8. RISK AND LIABILITY

- 2.4 In the case of the intervention of any outside act, agent or event which naturally changes the result or prevents or hinders its determination, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest or strikes, the Promoter may, in its absolute discretion, cancel the Promotion and/or recommence it from the start on the same conditions subject to state legislation.
- 2.5 If the Promoter becomes aware that a winner is in breach of any warranty contained in these Terms and Conditions or made subsequently to, The Promoter may deem that winner ineligible.
- 2.6 Except for any liability that cannot be excluded by law, The Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following:
- i. any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
 - ii. any theft, unauthorised access or third party interference;
 - iii. any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by The Promoters) due to any reason beyond the reasonable control of the Promoter;
 - iv. any variation in Prize value to that stated in these Terms and Conditions of entry;
 - v. any tax liability incurred by the winner or entrant; and/or
 - vi. redemption of the prize.
